Adult Elementary Modern

- One/Two years previous training suggested.
 - Technique and vocabulary of movement underlying contemporary dance forms.

Adult Intermediate/Advanced Modern

- Three years previous training suggested.
 - Technique and vocabulary of movement underlying contemporary dance forms.

Adult Elementary Jazz

- Adults with one year of previous dance training.
 - Technique and vocabulary of movement seen in variety shows, music videos and musical theatre.

Adult Intermediate Jazz

- Adults with two year of previous dance training.
 - Technique and vocabulary of movement seen in variety shows, music videos and musical theatre.
-

Adult Advanced Jazz

- Adult students with a minimum of three years of training.
 - Experience with the technique and vocabulary of movement seen in variety shows, music videos and musical theatre.

Conditions of Enrolment

- There is a \$20 registration fee payable on the initial adult registration at The School.
- There are no refunds except in the case of cancellation.
- All registration forms must be signed and dated in order to be eligible to take part in classes.
- Fees are due in full at time of registration.
- Family discount of 10% must be mentioned when registering.
